

2025 Landside Holiday Moratorium Dates

Waiver

You may request a waiver to establish a new construction zone, roadway/lane closures or utility outages during the moratorium.

Submit waivers two weeks in advance of closure or by COB:

- 5. If approved you will receive an approval email from Sabine Schleigh.

Work Zone Awareness













1. Yodocks

If you have these in your work zones. Do not fill to the full capacity. Fill to 70-80 percent to avoid burst in cold temperatures.

Drums, Panels, and Candlesticks

Keep all devices clean, in line, and evenly spaced per TMUCD Standards.

Signs, Barricades and Lighted boards

Devices must be clean, clear, and in line of sight to oncoming traffic. Flashing lights must be operational.

Mud Tracking

Do not track mud on public roadways. If you should track mud, dirt, or debris, you must immediately clean, and clear the roadway.

5. **Water Ponding**

The contractor must take immediate action upon ponding in the roadway. Follow Environmental guidelines to use a water filter to drain clean water into into an open drain.

Contractor Parking

Contractors must provide adequate parking spaces for employees, and must not conflict with the public roadway for entering and exiting with track mat in place for mud tracking. Plan must be approved prior to the start of construction.



Note: Ice, rain, heavy winds, and driver inattention can create a road hazard to your work zone. Please check your zones daily to prevent any incidents.

Contractors will now be fined for not upkeeping or complying with DFW Work Zone Requirements.


1st Notice - Contractor will be notified, and must correct immediately (as defined by the Traffic Engineer)

2nd Notice – Contractor will be required to correct the problem within 24hr.

3rd Notice – A \$75.00 fee will be applied to the permit, and your permit inspections will be placed on hold until the fine is paid, and the problem is corrected.

Work Zone Flooding – Maintaining SWPPP

Storm drains and curb inlets should be protected with filter fabric and filter socks, which trap sediment and allow water to flow through.

Work Zone Mandatory Requirements



1. FLAGGER

To keep safety at the forefront, and to provide additional protection for workers and the public. A flagger <u>MUST</u> be present when your work zone is:

- a. Next to an active lane
- **b.** On roadways with high traffic

Examples: International Pkwy, Walnut Hill, & Service Roads



2. IMPROVING VISIBILITY

Install yellow reflectors on every other drum on the first taper of your traffic work zone. This only applies to work zones areas at speed limits of 45 MPH or above.

3. SPEED LIMIT REDUCTION & TRAFFIC ENFORCEMENT

If speed limits are posted <u>45 MPH</u> or above. It's required to follow as noted:

- a. Install Work Zone Traffic Fines Double sign in advance to your Road Work Ahead sign.
- **b.** Install regulatory **Speed Limit** sign with your **Work Zone** sign. This applies to <u>45 MPH</u> and above, or as directed by the Engineer upon the roadway conditions.
- c. For the use of road work closures on International Pkwy. A **DFW Airport**Law Enforcement Officer must be present during construction.
